## **REGULAR MONTHLY BOARD MEETING**

#### <u>Call to Order</u>

Larry Folks, Vice-Chairman called to order the meeting of the Sweetwater County Conservation District (SWCCD) at 4:00 PM on September 5, 2024, at 550 Uinta Drive, Suite E, Green River, WY 82935

Roll Call and Pledge of Allegiance

Larry Foks, Vice-Chairman conducted a roll call and introductions. The following people were present.

#### <u>Minutes</u>

A **motion** was made by Jean Dickinson, seconded by Henry Bliss, to approve the August 5, 2024, regular minutes as written. Motion carried.

#### <u>Agenda</u>

A <u>motion</u> was made by Jean Dickinson, seconded by Stephanie Anderson, to approve the agenda as presented. Motion carried.

#### Treasurer's Report

A motion was made by Jean Dickinson, seconded by Henry Bliss, to approve the Treasurer's Report, and pay the bills in the amount of \$12,124.53. Motion carried.

<u>Department of Audit: Internal Self Audit – For Special Districts</u> The worksheets include Proof of Cash, Internal Control, and an Annual Report Summary. Reports are all due September 30, 2024. Henry Bliss is completing the audit. Staff sent the Proof of Cash worksheet to Jonny Lamb, accountant, to complete.

A <u>motion</u> was made by Jean Dickinson, seconded by Stephanie Anderson, to approve the Annual Census Report/Internal Self Audit. Motion carried.

Reconciliation Report

A <u>motion</u> was made by Jean Dickinson, seconded by Henry Bliss, to approve the reconciliation report for April, May, and June 2024. Motion carried.

## Unfinished Business

Bitter-Killpecker Creek Update and Actions Drop Structure – Conference Call

The Board spoke with Russ Hamilton, WWC, with questions on the Bitter Creek Drop structure review memo, structure observations and recommendations.

- Hamilton relayed that some construction inspection logs, and lack of information is sparse on construction for the existing project.
- Hamilton explained they would work with SWCCD to develop a plan for moving forward with a new design. WWC can develop a milestone table with associated tasks.

Hamilton will follow up with the engineering firm that would do the geotechnical review if the exploration could be completed this fall. (estimated 40k to do the core sampling).

• Staff sent the WWC memo to Little Snake CD. Hamilton will follow up with Larry Hicks/Mark Blakley from LSRCD and the SWC Engineer.

### Grant Proposal for the Bitter Creek Drop Structure

- WWC Engineering can put a proposal together to write the grant for the Upper Basin Environmental Drought Mitigation through the IRA.
- Accepting grant applications through October 14, Russ said that does not give WWC very much time to prepare the grant.
- Preliminary design would be included in the grant proposal, but pre-engineering is not an option due to grant time constraints.

After discussion, the Board decided to hold off writing the grant this year and potentially pursue it again in 2025.

#### Bitter Creek Pathogen

Water Quality Monitoring - Bitter Creek Pathogen 2024 monitoring on Rock Springs sites continues:

The *E. coli* samples collected on 8/12/2024 from BC-3, BC-3A and BC-4 on Bitter Creek and KC-1 on Killpecker Creek by WWC Engineering in coordination with the Sweetwater County Conservation District have been evaluated by the Department of Environmental Quality (DEQ) for consistency with validation requirements.

-The results from the 8/12/2024 sampling event at site **KC-1** on Killpecker Creek remain above the recreational use threshold of 235 organisms per 100 mL identified in the <u>Waterborne Pathogen Public Notification Process</u>

-The results from the 8/12/2024 sampling event at site **BC-4** on Bitter Creek are above the recreational use threshold of 235 organisms per 100 mL

-The results from the 8/12/2024 sampling event at sites **BC-3 and BC3-A** on Bitter Creek are below the recreational use threshold of 235 organisms per 100 mL

The Sweetwater County Board of Health has posted signage at the sites where the exceedances are observed which advise the public to avoid contact with the water.

### Sampling and Analysis Plan (SAP) - Bitter Creek Project

A revised SAP for the Bitter Creek Project now includes Addendum 1 to incorporate use of the SWC Environmental Health Lab to conduct sample analysis for the water quality sampling and pathogens.

BLM Rock Springs Field Office (RSFO) Jackalope Wind Project

- SWCCD received an invitation to Participate in Developing a Programmatic Agreement (PA) for the Proposed Jackalope Wind Project.
- SWCCD requested to participate in the PA development process for the Jackalope Wind Project.
- BLM said that an initial meeting will be held sometime in September. Staff will update the Board when information becomes available.

### Cattle Chute

- Staff will check with Burris on the status of the chute.
- Update: Burris said the chute is at the repair shop and he will call and find out when the chute will be available.

## Area V Meeting - SWCCD Host

The area meeting will be held on September 25, at the Green River College Campus meeting room. Staff sent the invite, agenda, map and 2023 minutes to Area V participants.
